- 3 A Termination Charge of 100% of the Monthly Recurring Charge for the remaining service contract period is payable for any premature termination of this service.
- 4 No downgrading of Service Plans is allowed within the Service Contract period. A "downgrade" is defined as changing to a Service Plan with lower Monthly Recurring Charge. Any downgrading shall be treated as a termination, for which customer is liable to pay the charges stated in Clause 2 and/or Clause 3, whichever is applicable.
- 5 Any relocation of the installation site address shall be treated as termination, for which customer is liable to pay the charges stated in Clause 3.
- 6 A cancellation charge of S\$950.00 (inclusive of GST) is payable for any change of installation site address upon receipt of ZONE order confirmation acknowledgement.
